The FCC has released a First Report and Order on restructuring effective July 23, 1976. The major effect is on Technician and Novice class licenses, with Technicians receiving full

Novice privileges and Novices having an increased power level of 250 watts. Also, higher class licensees operating in the Novice bands will be limited to the same 250 watts. FCC's reasons for this change as stated in the official Report and Order is "for two reasons; firstly, it will mean that a Novice can buy equipment which will be readily useable and practical when he upgrades to General Class and above. Presently, in order to conform to the 75 watt power limit, Novices oftentimes are forced to buy low power transmitters which they find have limited usefulness outside Novice sub-bands; and secondly, we see no reason to permit non-Novices to utilize high power in a sub-band where such power gives them a significant advantage over a license class which is restricted to that sub-band."

Another significant change is that the Conditional class license will no longer be issued and current Conditional licensees will be issued General class licenses at renewal, and will be given full credit for all exams taken by mail, i.e. in order to upgrade to Advanced a Conditional class licensee will only have to take the Advanced written test. The same applies to Technician(C) class, and henceforth all Technician tests will be given only at FCC examining points. Mail exams will be available only for Novices and those with a protracted physical disability who can furnish a physician's certificate to that effect. In stating its reasons for discontinuance of mail-order licenses FCC notes that in a "routine call-in program of Technician(C) and Conditional Class licensees has shown that over 90% of such persons either fail to appear for re-examination, or if they do appear, fail the examination." (!!)
