



## EDITORIAL-TYPE COMMENTS

Section 605 of the Communication Act of 1934 was ammended June 19, 1968, and all people should be aware of what it is all about. Have a copy of the entire Section if anyone wants to see it. Basically, it says that if you are listening to a Police Monitor, you are forbidden by law to repeat anything you hear.

This Section does not apply to the receiving, divulging, publishing, or utilizing the contents of any radio communication which is broadcast or transmitted by Amateurs or others for the use of the general public, or which relates to ships in distress.

Haven't seen too many ships sailing around this area just recently, so be careful what you repeat.

Also, be certain your use of the Auto-Patch is legal. There are specific rules as to which calls can be made and which cannot.

## Each call must be listed in your Log.

Quite a few places in the United States have lost their Auto-Patch privileges because of illegal activities. Let's make certain it doesn't happen here.

Gene, KØCKX, brought his well laden camper and stayed the night to protect the equipment. Actually, he stayed there from Friday night until Sunday afternoon.




